2018 Organization Application

Thank you for your interest in the Charity of Choice program! The goal of the Heart Haven Hustle 5K Run & 1 Mile Fun Walk is to unite community organizations and local charities in recognition that we can effect greater change by working together. The Charity of Choice program enables anyone to raise money for his or her cause of choice through participation in the Heart Haven Hustle. To get started, simply register to run or walk with us on Sunday, October 14, 2018, and then collect donations and pledges, 100% of which go to your organization. This form is required to become an official Charity of Choice in the Heart Haven Hustle.

Instructions:

- You must register for the Heart Haven Hustle 5K Run & 1 Mile Fun Walk and pay your registration fee before collecting pledges. **Pledges do not count toward your registration fee.**
- You are welcome to raise pledges to support any charity, organization, or cause of your choice.
- We encourage you to **notify us if you will be collecting pledges**. This will help us direct questions and contributions appropriately. Simply email info@HeartHavenHustle.org with your name or your adult team leader's name, the name of your charity or organization, and a phone number or email address at which we can reach you or your team leader with any questions.
- It is your responsibility to give any contributions collected directly to your chosen charity or to your adult leader. (It is suggested that youth under the age of 18 have a designated adult leader overseeing fundraising efforts.) Heart Haven Hustle is not responsible for collecting or distributing funds raised through the Charity of Choice program.
- **It is recommended that you collect checks** for both your and your donors' safety. The canceled check will serve as their contribution record for tax purposes, unless you have made arrangements with your charity of choice to provide formal receipts. (Formal receipts are required for contributions of \$250 or more.)
- **It is your responsibility to find out whether or not contributions to your charity of choice are tax deductible and to inform your donors accordingly.** Not every charitable cause is a federally approved nonprofit organization. You can visit <http://www.irs.gov/Charities-&Non-Profits/Exempt-Organizations-Select-Check> to find out if your organization is eligible to receive tax-deductible contributions.
