Dear Parent/Guardian:

Your son or daughter has expressed interest in participating in this year's Eight Annual "Character Counts 3-on-3 Basketball Tournament." This tournament has been put together to give any teen interested in playing basketball the chance to be involved on an organized team. We understand that not every teen who wants to play is always given the opportunity, whether it is due to lack of open spots on the team, different skill levels, or inability to afford the fees. Heart Haven OutReach (H₂O) will be putting together a month of basketball to make it possible for teens to play in a safe, fun, and affordable environment.

To participate, all players must turn in a completed Registration Form, Permission Slip & Release Form, and \$5 registration fee (which will cover the cost of a team shirt). Forms may be picked up at H₂O or from your child's school. They can also be downloaded from www.HeartHavenOutReach.org. **The two forms and the \$5 fee are due by Thursday, January 31st.** All players must be in good standing with their school as pertaining to grades, behavior, and attendance.

All players will be required to attend practices during the month of February if they want to play in the tournament. The practice schedule will be set February 2nd, and emailed or texted as soon as the schedules are available. During the first practice, players will have an orientation about the tournament, get to know their coach, and go over expectations

Practices with their assigned coaches will be a place where basketball skills are developed and worked on, character on the court will be taught, and mentoring from the coaches will be given. We require at least three practices from each team to ensure each player has a solid understanding of the game, teamwork is in place, and meaningful relationships are built with the coaches. Our coaches are community members who have gone through background checks and are volunteering their time to give your son or daughter the chance to play basketball and work on their skills. Different gyms have opened up their facilities for practicing around the community. They will include the Bolingbrook Community Center, Bolingbrook Park District, New Life Church, Romeoville Rec Center, and Living Water Church.

The tournament will take place on the afternoon of Sunday, March 3rd at Brooks Middle School at 350 Blair Lane in Bolingbrook. The tournament will be set up as a bracket play, splitting the high school and middle school students into separate tournaments. Game times for each team will be given the week prior to the tournament. We encourage you to come this day and cheer for your son or daughter's team. Tickets for the event will only be \$1 and will be sold at the door.
