The Christian Focus of Heart Haven OutReach

Heart Haven OutReach seeks to have a Christian focus in approaching the difficult issues youth and families face today. In the course of providing youth and family services, people often struggle with issues that are controversial in the religious context, within which we and they operate. While individual staff have room for varying beliefs concerning these issues, our stance as an organization is to be consistent with Scripture.

The Greek word for sin in the Bible is "hamartia," which means missing the mark. Sin, or missing the mark, disrupts people's lives in many ways. Individuals may experience the negative ramifications of missing the mark to some degree in all areas of their lives: social, spiritual, psychological, emotional, and physical.

Having experienced the negative effects and emotional pain of missing the mark in some area of life, people seek help from Heart Haven OutReach. It is the goal of Heart Haven OutReach to approach people's problems in the realm of every day reality, not simply theology. The help given at Heart Haven OutReach is not in the form of legislating behaviors and attitudes. Rather, counsel is provided to help program participants recover from the negative consequences of missing the mark, and to equip them to hit the mark more successfully starting in the present.

New employees shall not have access to a grievance procedure in regard to discharge during the probationary period. New employees should reference the organization evaluation form. I also understand that my employment status is as an "At Will" employee and may be terminated at any time by either party.
